DEAR FRIENDS OF IDAHO—

The year 2000 was a pivotal year for the Idaho Community Foundation.

It was the year in which our asset total briefly exceeded \$50 million, although fourth quarter grants, the cumulative effect of a change in accounting principle, and declining financial markets late in the year took the asset total back to \$47.8 million by December 31. ICF's 47% growth in assets during 2000 was largely due to a very generous \$15 million bequest from Gladys Langroise, a prominent Boise philanthropist.

Two thousand was also the year in which we left the offices graciously provided since our beginning by U.S. Bank and moved into a home of our own at 210 West State Street in Boise—four blocks from the Capitol building. This new home is totally paid for, thanks to the generosity of supporters throughout Idaho who responded to the fund drive led by our former chairman, John Fery.

The Idaho Community Foundation was incorporated in November of 1988. By 1991, the Foundation had attracted sufficient assets to begin a modest state-wide grantmaking program, distributing \$113,000 that year. Since that modest beginning, ICF's grantmaking has grown to the point where we are now distributing over \$2 million each year from a wide variety of endowed and non-endowed funds.

We have focused on relatively small grants of up to \$5,000, with the exception of grants we make on behalf of the J. A. and Kathryn Albertson Foundation for educational projects. These can be as large as \$25,000 and are aimed at improving Idaho's kindergarten through 12th grade education. The grants also assist early childhood programs which help children succeed when they start school as well as after school programs with a strong education component.

Each year ICF evaluates its approach to grantmaking, asking ourselves whether we should be making fewer but larger grants. So far the ICF board has remained convinced that small grants can provide vital seed money for needed projects—particularly in rural Idaho, where the need is great and philanthropic dollars are in short supply. Further, we believe that ICF's statewide structure allows us to do this type of grantmaking particularly well.

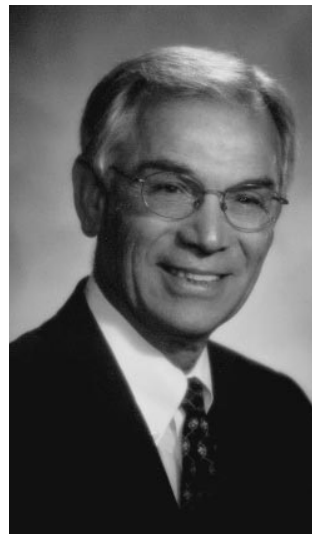

The funds available for grants come, of course, from the generosity of ICF's many donors. We are proud that at yearend 2000, there were 242 active funds in the Foundation, established by organizations and individuals with a tremendous variety of interests. The individual funds are as large as \$15 million, but anyone who can pledge and pay \$5000 over a five-year period may have a fund in the Idaho Community Foundation. ICF services are available to everyone. We believe that one of the great strengths of the Idaho Community Foundation is its ability, quickly and efficiently—at no cost to the donor—to develop a fund document which will meet the donor's wishes in perpetuity.

Management of the Foundation's investment portfolio is a critically important fiduciary responsibility which the ICF board takes very seriously. Few investors were pleased with the performance of the financial markets in the year 2000, particularly in the last quarter, and ICF was no exception. Although the Foundation's investment performance was essentially flat—down .5%—we did outperform the market for the year. We continue to believe that our investment policy, which is based on long-term objectives, is appropriate. For more information on investments, please turn to page 51.

We are especially grateful to John Fery, Boise, and Bill McCann, Jr., Lewiston, both of whom retired from the board in 2000. John was ICF's founding chairman, and without his vision and energy, it is unlikely that Idaho's statewide foundation would be a reality today. Bill represented the

ABOUT THE FOUNDATION

A COMMUNITY FOUNDATION is a tax-exempt public charity that enables individuals and organizations to establish charitable funds. Each fund has its own legal document and is accounted for separately. The funds are pooled for more efficient and cost effective investment management.

The Idaho Community Foundation is Idaho's only statewide philanthropic organization supported by the public with private funds, assisting a broad range of charitable, cultural, and education projects statewide.

HISTORY Established in 1988 with major assistance from Caldwell's Whittenberger Foundation and the Council on Foundations to broaden and deepen Idaho's pool of philanthropic capital.

GOVERNANCE Provided by a volunteer board of directors representing Idaho's diverse geography (see page 55 for a list of directors). Directors are elected by ICF's members, who also select the Foundation's independent public auditors, and serve as a communications network for ICF (see page 53 for a list of members, and contact the Foundation office for information on becoming a member). The Foundation's bylaws provide that none of the state's three regions—Northern, Eastern, or Southwestern—can have less than 25% or more than 48% of the Foundation's membership or board, thus ensuring that no one region may dominate the Foundation's affairs.

ASSETS AND ENDOWMENT Total assets of the Foundation at year-end 2000 were \$47.8 million. Endowment was \$38.9 million. The difference between total assets and total endowment is comprised of special project funds and philanthropic gift funds which may be fully expended and therefore are very conservatively invested.

A FUND IN THE FOUNDATION This is an individual account created by the contribution of a donor or group of donors. Each fund carries a name chosen by the donor or donors. That name and the guidelines established when the fund is created, become its distinguishing characteristics in perpetuity (see page 7 for a list of ICF fund types).

- Anyone can create a Foundation fund. Individuals, companies, nonprofit organizations, and other foundations have created funds.
- A person need not be wealthy to establish a "named fund" in the Foundation. Such a fund can be established with a minimum contribution of \$5,000 in assets (or a pledge payable within a maximum of five years).
- Anyone may add to any fund in the Foundation, in any amount, at any time.

FEES AND CHARGES There is no fee to establish a fund in the Foundation, and a minimum of paperwork is required.

- Most endowment funds are assessed an annual management fee of 1%, with .25% being assessed at the end of each quarter on the average market value of the fund.
- Endowment funds created by nonprofit organizations (agency funds) are assessed an annual management fee of one half of 1%, with .125% being assessed at the end of each quarter on the average market value of the fund.
- For non-endowed philanthropic gift funds there is no charge related to monies which remain in the fund for at least six months. ICF, however, retains the earnings on the fund. Monies expended from a philanthropic gift fund in less than six months are charged 2%.
- For special project funds which provide for the total expenditure of the contributions and earnings, ICF assesses 2% of each contribution. For those funds in existence for six months or longer as of December 31 of any given year, an additional 2% fee will be assessed in January based upon the average market value of the fund during the previous year.

Additionally, each fund, on a quarterly basis, is assessed its pro-rata share of the fees paid to ICF's investment managers. These fees in 2000 ranged from .06% to .75%, depending upon the individual manager.

GRANTS ICF makes grants statewide to fund a broad range of activities, services, and projects of established 501(C) charitable organizations, or governmental units, or their subsidiaries. The Foundation considers requests for grants from its unrestricted, advised, and field-of-interest funds on a regional basis. Applications from the Northern Region are accepted November 1–February 1; from the Eastern Region February 1–May 1; and from the Southwestern Region May 1–August 1. Grant applications for a specified statewide project are accepted from August 1 to November 1

(The grant making process is described in detail in a separate brochure, available on request.)



TAX BENEFITS Since ICF qualifies as a public charity under federal regulations, gifts during a donor's lifetime or bequests to the Idaho Community Foundation are accorded the maximum tax advantages allowed by law. Major gifts to a community foundation such as ICF may qualify for special tax considerations and, in some cases, may be a

superior alternative to creating a private foundation. Potential donors should consult with an estate planning professional about their specific circumstances.

FLEXIBILITY ICF works with donors and/or their advisors to create a fund with terms and conditions designed to meet the specific requirements of each individual situation.

ECONOMY There is no charge to create a fund in the Foundation, and administrative and investment management fees are reasonable.

CONVENIENCE AND EFFICIENCY A minimum of paperwork is required to establish a fund in the Foundation, and ICF takes responsibility for all reports to the Internal Revenue Service and other governmental entities. One contribution to the Foundation can address a wide range of needs or interests, and can benefit any or a number of charitable organizations.

EFFECTIVENESS The Foundation ensures good use of donor gifts through the professional grant research of the staff, the prudent and informed judgment of the regional advisory panels which review and make recommendations on grant requests, and the oversight of the board of directors.

GIVING OPTIONS Almost any asset of value may be considered for a contribution. The Foundation can accept cash, securities, real estate, closely held stock, or other personal property. Funds may be established with pledges payable within five years. Contributions can be made during the donor's lifetime and/or through deferred gifts and bequests.

PERPETUITY The agreement drawn to create an endowment fund in ICF ensures that the Foundation will honor the donor's charitable intent in perpetuity.

RECOGNITION Each grant from a fund is identified to the recipient by the name of the donor and/or the name of the fund designated by the donor. Donors can, of course, request anonymity with the assurance that their wishes will be respected.

INVESTMENT EXPERTISE Donors are assured of professional management of the Foundation's assets by experienced investment professionals, with oversight by the Investment Committee of ICF's board of directors.

ACCOUNTABILITY For investment purposes, endowment funds are pooled in order to receive better returns at lower costs. For accounting and reporting purposes, however, each fund is maintained as an individual, named entity, with separate tracking of earnings, pro-rata fees, and grant disbursements. The Foundation's financial records are subject to ongoing oversight by the board of directors and an annual independent audit.

GRANTS OUTSIDE IDAHO Each fund in ICF must be of substantial benefit to Idaho, but fund creators may structure their funds so that some of the distributions go to charitable projects outside Idaho.

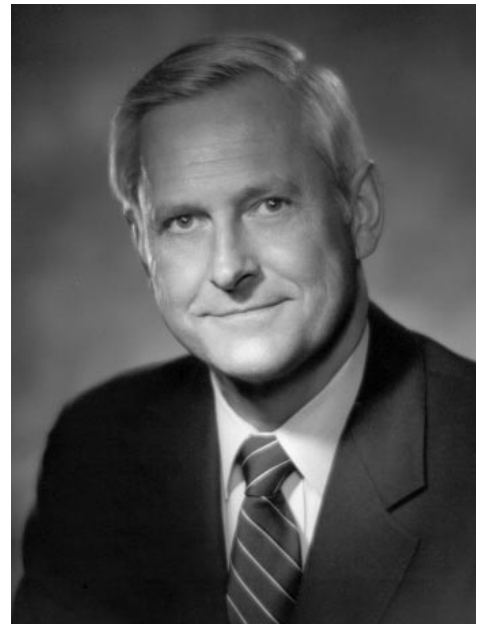

RIEND OF THE FOUNDATION

JOHN FERY of Boise was born in the state of Washington, but made Idaho his adopted home forty years ago. Since then, both during and after his long tenure as an officer of Boise Cascade Corporation, he has worked on countless projects to benefit his adopted state and its people. None, he says, has given him greater satisfaction than his service to the Idaho Community Foundation.

John chaired the steering committee which explored the concept of a community foundation for Idaho and became the new foundation's founding chairman when it was incorporated in November of 1988. Many community foundations serve a city, county, or region, but under John's leadership, Idaho's foundation was established with a statewide scope in order to provide the benefits of a community foundation to all of Idaho.

John was determined that the Idaho Community Foundation would have an operating endowment to help in perpetuity with its ongoing administrative expenses, and he led a volunteer team that convinced primarily the business community to contribute an operating endowment that now totals over \$1 million. Boise Cascade made a major contribution to this fund and established a separate ICF operating fund in John's honor upon his retirement as Boise Cascade's chairman and CEO in 1994.

After serving for eight years as ICF's chairman, John became chairman of the Foundation's Asset Development Committee, providing strong leadership in growing the asset base which is critical for grantmaking.

John and his wife Dee have been generous in their own financial support of ICF. They have established an advised fund in excess of \$100,000, have provided for ICF in their estate planning, and as John led the drive to raise funds for the purchase of ICF's new home, they contributed \$50,000.

Leadership is the critical ingredient in the long-term success of any organization. All of us associated with ICF will be forever grateful to John Fery for the leadership, commitment, and vision which were so important in making the Idaho Community Foundation a permanent resource for Idaho. He is indeed a Friend of the Foundation.



FOUNDING DONORS

The Idaho Community Foundation owes its existence to the foresighted individuals, corporations, and organizations which joined together to create and endow the Foundation. Our Founding Donor campaign concluded December 31, 1992, having raised a total of \$5 million. 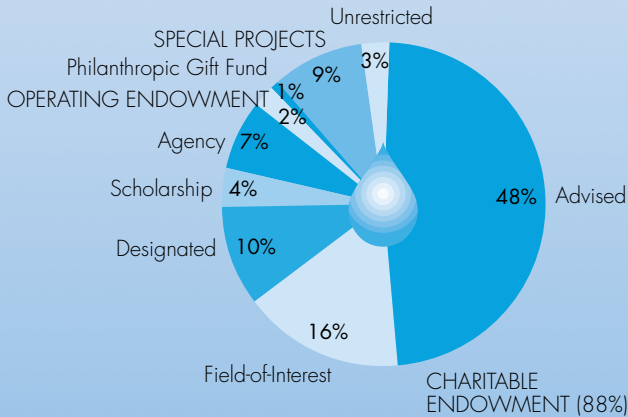

2000 ASSETS OF THE FOUNDATION BY TYPE OF FUND



The Idaho Community Foundation offers a broad range of choices for donors, be they individuals, private foundations, corporations, or other charitable organizations. However modest or bold the philanthropic objective, ICF is available to help.

CHOICES:

AN UNRESTRICTED FUND: The donor's gift provides the Foundation with maximum flexibility in meeting needs throughout Idaho. Distributions from an unrestricted fund are made at the discretion of ICF's regional advisory panels and board of directors, ensuring that the gift will always address current issues. Contributors of \$5,000 or more have the privilege of naming their fund.

AN ADVISED FUND: Donors of \$25,000 or more may retain the privilege of participating in the selection of beneficiaries of their fund. While IRS regulations require that each final decision must rest with the Foundation's board of directors, the advice given by donors is fully considered in making grants from these funds.

A FIELD-OF-INTEREST FUND: This option allows donors of \$25,000 or more to limit grants from their funds to organizations or projects within a particular charitable field, geographic area, or combination thereof. The Foundation determines the annual beneficiaries of these funds within the bounds of the donor's wishes.

A GEOGRAPHIC FUND: These are created to benefit a particular city, county, or otherwise defined geographic area by an individual or group of individuals who join together to contribute a minimum of \$25,000. Distributions from the fund are made only within the defined geographic area, and are based on recommendations of a local advisory committee.

A DESIGNATED FUND: Donors of \$25,000 or more may ensure long-term annual support to the charitable organization chosen at the time of the fund's creation. Should the designated organization cease to exist or become dysfunctional, the Foundation has the contractual ability to redirect the income in accord with the donor's original intent.

A SCHOLARSHIP FUND: Donors of \$10,000 or more may customize a scholarship fund to provide educational opportunities for graduates of certain schools, for studies in specific fields, or for programs at particular institutions of higher education.

AN AGENCY FUND: A charitable organization can protect its capital for the future and obtain the economies and rewards of participating in a larger investment pool by placing its

endowment with the Foundation. Earnings from the fund are regularly disbursed to the participating agency for use as its board of directors deems appropriate. Contributors may add to the fund with any amount, at any time.

AN OPERATING ENDOWMENT FUND: Earnings generated by these permanent funds help to offset the operating costs of the Foundation and reduce the administrative fees that might otherwise have to be assessed to other funds of the Foundation. Contributors of \$5,000 or more have the privilege of naming their funds.

AN ACORN SOCIETY ACCOUNT: Donors can make donations to an account on a regular basis until attaining the minimum required to create the fund of their choice. A named fund can be created for as little as \$5,000. With an Acorn Society account, both donor contributions and accumulated fund earnings are credited toward attainment of the established dollar goal for the fund. The concept allows participation in the Foundation by those with a desire to do something of lasting significance for the Idaho community, but who would prefer to make the contribution over time.

THE LEGACY SOCIETY: Donors preferring to make a deferred gift may choose to name the Foundation as the beneficiary of a charitable trust, will, bequest, or other deferred giving instrument. Those willing to be recognized are named and thanked in the annual report as members of the Legacy Society. In many instances, the deferred gift donor receives benefits such as income or other use of property during his or her lifetime. Upon the donor's death, the remaining principal is transferred to the Foundation, and the earnings become available for charitable use as specified by the donor. Funds created through deferred gifts

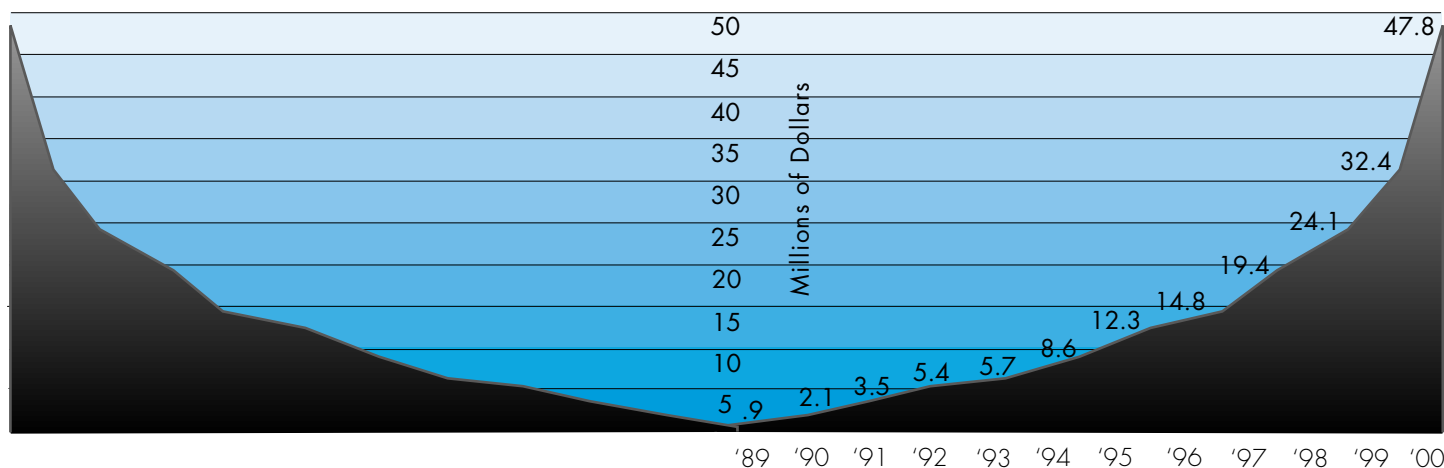
offer permanent recognition for the donor's philanthropic service to the community.

A PHILANTHROPIC GIFT FUND: With a contribution of \$5,000 or more, a donor may establish a non-endowed, fully expendable fund from which the donor or donor-specified advisors may recommend distributions of \$250 or more to any IRS recognized charity at any time. The donor is not required to maintain a minimum balance in the fund. Advantages of such a fund include the ability to make tax-deductible donations of appreciated assets at a time of the donor's choice, thus bypassing capital gains tax liability, while the donor advises on the amount and timing of subsequent gifts from the fund.

A SPECIAL PROJECT FUND: The Foundation occasionally serves its statewide community by receiving and managing non-endowed funds to support a special project. Such non-endowed gifts differ from endowment in that contributions, as well as the net income earned while the assets are held, will be expended in the near future.

A SUPPORTING ORGANIZATION: These may be created by donors who choose to affiliate with the Idaho Community Foundation by creating a new entity or transferring an existing fund or private foundation. Supporting organizations maintain their own identities while taking advantage of significant tax savings through their affiliation with ICF. Donors may participate actively in grantmaking and administration of the supporting organization, while receiving the professional support services of the community foundation. ICF may appoint a majority of the directors on the supporting organization's board.

Since grantmaking began in 1991, the Idaho Community Foundation has distributed more than \$10 million for worthwhile philanthropic projects.

TELL US WHAT YOU NEED ICF's mission is to enrich life's quality throughout Idaho. We intentionally don't define what that means. Officed as we are in Boise, we think it would be presumptuous for us to determine what's needed to make life better in communities all over Idaho. We rely on the grant applications submitted during the three regional grant cycles to tell us what people in towns throughout the state believe could make life better where they live. Because the needs are so varied, the range of projects funded by the Idaho Community Foundation is exceptionally broad, as indicated by the list of grants made in 2000.

THE REGIONAL ADVISORY PANELS In order to receive grass roots input on the competitive grant applications, ICF relies upon the recommendations made by its Northern, Eastern, and Southwestern Region Advisory Panels. The community leaders who serve as volunteers on the panels have the demanding task of carefully and objectively analyzing the grant applications from their respective regions. Membership on the regional advisory panels is shown beginning on page 55 of this report.

GIVING WHERE THE DOLLARS MAKE A DIFFERENCE ICF's individual competitive grants to date have not exceeded \$5,000. This is because rather than making a few large grants each year, we are interested in helping many Idaho communities—providing philanthropic capital in towns where charitable dollars are often very hard to find. We like the idea of making grants that can be leveraged to produce an improved result for the community.

WORKING WITH DONOR ADVISORS The grantmaking process of the Idaho Community Foundation gives ongoing consideration to the desires of donors who have established funds in the Foundation. Many advisors review grant applications ICF has received before recommending a distribution from their fund in a given year.

GIVING WHERE DONORS HAVE ESTABLISHED FUNDS We are often asked why some geographic areas seem to fare much better than others in terms of the grants they receive from the Idaho Community Foundation. The primary reason is that some areas benefit directly from endowment funds established by donors, with the distributions directed in perpetuity to those specific areas. Gem County and Blaine County are good examples of this.

GRANTS OUTSIDE IDAHO Each fund established in the Idaho Community Foundation must be of substantial benefit to Idaho. Within this guideline, ICF believes it is appropriate to consider the advice of donor advisors who, while recommending distributions to Idaho charities, also may recommend distributions in other states where they have roots and connections.

PARTNERSHIPS Synergy can be an over-used and sometimes abused word, but in the philanthropic world, partnerships often can create synergy. We at the Idaho Community Foundation feel especially fortunate to be working with the J.A. and Kathryn Albertson Foundation and The Steele-Reese Foundation in the pursuit of their respective missions—which mesh with our own.

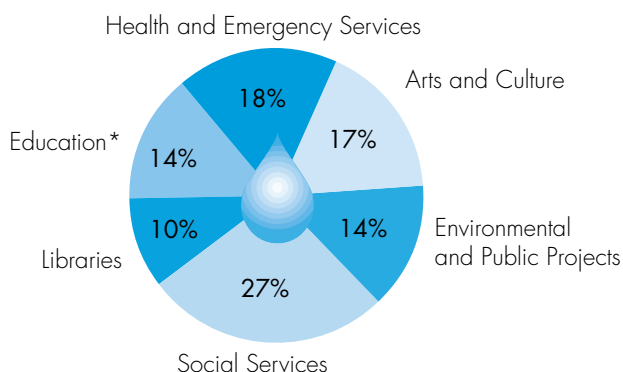
The generosity of Joe and Kathryn Albertson is legendary. They always shared the fruits of their supermarket success with Idaho. As ICF was first being established, the Albertsons provided a large unrestricted fund to benefit communities statewide. They also established an operating endowment. The relationship with their foundation has been especially meaningful for ICF, and has yielded some of our most satisfying experiences with grant beneficiaries—children all over Idaho.

Working through the ICF regional advisory panels, we make competitive grants ranging in size from a few hundred dollars up to \$25,000 on behalf of the J. A. and Kathryn Albertson Foundation for creative education projects in pre-kindergarten through the 12th grade, early childhood education, and after school programs with a strong education component. Since we began working with the Albertson Foundation in 1997, ICF has distributed \$3,038,000 in education grants throughout Idaho—providing the funding for the types of projects which often don't quite make it into a tight school district budget, but may be just the thing to make students excited about learning. All the grants are aimed to increase student learning.

The Steele-Reese Foundation was established by a remarkable woman named Eleanor Steele-Reese, who for many years owned and operated a working ranch near Salmon. Although she came from a wealthy eastern background, she became passionate in her concern for people living in rural areas. She and her husband, Emmett, were especially interested in helping people and organizations to help themselves. As is the case with the J. A. and Kathryn Albertson Foundation, Steele-Reese makes many significant grants each year. The Idaho Community Foundation board works through its regional advisory panels to make relatively small, but very helpful grants on behalf of The Steele-Reese Foundation.

DEVELOPING YOUNG LEADERS Youth involvement grants are becoming a signature project for the Idaho Community Foundation. Since 1998 we have provided grants of as much as \$2,500 to groups of young people, ages 8 to 18, who have identified a problem involving youth in their town, have developed a solution, applied through an adult organization for a grant, raised a match in cash, donated labor, or materials, and then have implemented their project. Our objective is to develop young leaders by giving them a chance to lead. We are always looking for individuals and organizations who might like to work with us in funding a project of this type in their community. Grants from this program in the year 2000 were deferred to 2001 in order to have a funding cycle separate from the three regional cycles.

GRANT GUIDELINES

ICF makes grants to fund activities, services, and projects of established 501(c) charitable organizations or governmental units or their subsidiaries, consistent with ICF's mission "to enrich life's quality throughout Idaho." The Foundation is especially interested in providing assistance to organizations seeking to meet emerging community needs.

Currently there are three regional grant cycles and one statewide grant cycle annually:

- The Northern Region call for proposals begins on November 1 and closes on February 1 with final approval by the board of directors scheduled for their May meeting.
- The Eastern Region call for proposals begins on February 1 and closes on May 1 with final approval by the board of directors scheduled for their August meeting.
- The Southwestern Region call for proposals begins on May 1 and closes on August 1 with final approval by the board of directors scheduled for their November meeting.
- The Statewide cycle call for proposals begins on August 1 and closes on November 1 with final approval by the board of directors scheduled for their February meeting.

ICF accepts grant applications only during the cycle specified for the region in which the proposed grantmaking activity will be undertaken.

Favored Activities:

In general, the Idaho Community Foundation favors activities that:

- Reach a broad segment of the community, especially those citizens whose needs are not being met by existing services that are normally expected to be provided by private rather than government sources
- Request seed money to realize unusual opportunities to meet urgent needs in the community
- Stimulate and encourage additional funding
- Promote cooperation and avoid duplication of effort
- Help make a charitable organization more effective and efficient and better able to sustain itself over the long term.



Low Priority Areas:

The following areas are of low priority to ICF and usually will not receive funding:

- Reduction of debt
- Grants to individuals (except scholarships)
- Fund raising projects
- Travel for individuals or teams
- Attendance at conferences, seminars or other projects
- Endowments
- Programs that fall more appropriately under government funding, such as operating expenses for public schools and police and fire protection
- Capital projects for which the Foundation's ability to contribute will be only a very small portion of the total budget and, therefore, will have very little impact on the success of the project.

The Foundation will not consider grants for:

- Religious organizations for the sole purpose of furthering that religion (this prohibition does not apply to funds created by donors who have specifically designated religious organizations as beneficiaries of the funds)
- Political activities or those designed to influence legislation
- National organizations (unless the monies are to be used solely to benefit citizens of Idaho or the organizations are specifically designated by the donor as beneficiaries of the fund)
- Grants that directly benefit the donor or the donor's family.



Funds in the Foundation which are not endowed and are fully expendable are invested conservatively in liquid instruments. Such funds include special project funds and philanthropic gift funds (see page 8 for further information.)

INVESTMENT MANAGERS ICF currently retains the following managers for the equity portion of its portfolio: Dimensional Fund Advisors, TCW Group, and The Vanguard Group. The Foundation's fixed income managers are First Security Bank, Key Trust of Idaho, and U.S. Bank.

The Investment Committee meets at least annually with individual representatives of the investment managers to discuss past performance and plans for the coming year. Strategic Investment Solutions provides performance measurement services as well as investment advisory consultation.

MANAGEMENT FEES Each fund in the Foundation is charged its pro rata share of the fees paid to the investment managers. In 2000 these fees ranged from 0.06% to 0.75%, depending upon the manager.

THE TOTAL RETURN CONCEPT

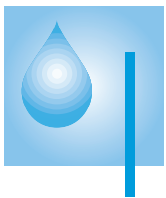
The Foundation has adopted the Total Return Concept (TRC) for the long-term management of its endowment assets.

Under the TRC, asset values, in other words, the income and appreciation of the assets' total market value, averaged over time, are taken into consideration in determining available grant dollars for each year's distribution.

The TRC allows the Foundation to be consistently responsive to current needs while positioning its funds to maintain the endowment's purchasing power and grantmaking capacity over the long term.

In accordance with the Total Return Concept, the Foundation board establishes a funding level each year which bases distributions on the average market value of an individual fund for the prior two to thirteen quarters, depending upon when the fund was established. This spending level is based on long-term earning trends, and not on results for any one year, and thus avoids severe fluctuations in dollars available for grantmaking.

By smoothing the market volatility and adjusting the spending rate annually, the Foundation maintains relative stability in the amount of funds available for charitable distribution and provides for increasing contributions over time, and protection from inflation.



INVESTMENTS

POLICY The Idaho Community Foundation believes in investing for the long term, recognizing that financial markets ebb and flow, and some years are better than others for different types of investments. For ICF, 2000 was a year in which the Foundation's investment performance did better than our policy benchmark, but still wound up essentially flat—down half of one percent for the year.

ICF has never based its distribution policy solely on earnings from a given fund in a single year. Rather, distributions have been based on the Total Return Concept—described below. The wisdom of that approach is being proven in 2001 as we continue with distributions not too different from those made in 2000, despite the performance of the past year.

INVESTMENT COMMITTEE The board's Investment Committee (see page 55 for membership) provides oversight for the investment process. The Committee's complete policy on investment and distribution of the Foundation's assets is available upon request.

The Investment Committee recommends to the board the asset mix for investment of the Foundation's endowment. At year-end 2000 the mix was 68% equities and 32% fixed income securities. The Committee also recommends to the board the investment managers which they believe can provide ICF with attractive relative returns and the appropriate degree of diversification and management style differentiation within this asset mix.

(1) Other assets include works of art which were contributed to the Foundation during 1994. In accordance with the endowment agreement, these works of art will be liquidated within a reasonable period of time, and the net proceeds from the sales will be added to the endowment fund. During 1996, the Foundation recorded an unrealized loss of \$1,445,448 to adjust the artwork to current net realizable value. This adjustment represents a reduction of \$1,016,471 in the value of the artwork and an increase of the allowance for estimated commissions and other selling expenses of \$428,977. The December 31, 2000 and 1999 other asset balances of \$864,995 and \$902,957 respectively, are net of allowance for estimated commissions and other selling expenses of \$1,154,812 and \$1,174,328 respectively.

(2) At January 1, 2000, the Foundation adopted Statement of Financial Accounting Standards No. 136, which specifically requires that if a not-for-profit organization establishes a fund at a community foundation with its own funds and specifies itself as the beneficiary of that fund, the community foundation must account for the transfer of such assets as a liability. The Foundation refers to such funds as agency endowments. The cumulative effect of this change in accounting principle was \$(2,278,245). For financial reporting purposes distributions from agency endowments are not included in Grants and Distributions for the year 2000.

In accord with ICF's bylaws, no one of ICF's three regions has more than 48% or less than 25% of the membership. Responsibilities include electing the Foundation's board, appointing its independent public auditors, and providing general advice and assistance

ICF offers a graduated membership fee structure to accommodate those members who wish to support Foundation operating expenses at more than the \$25 minimum cost of membership. Membership contributions are tax-deductible.

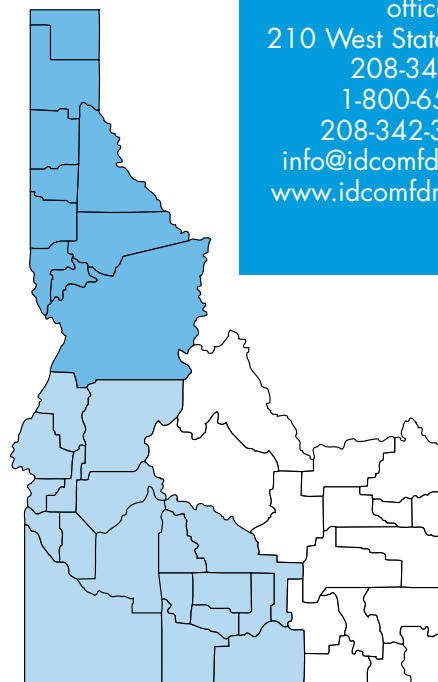
