Connecting Idahoans, Building Community



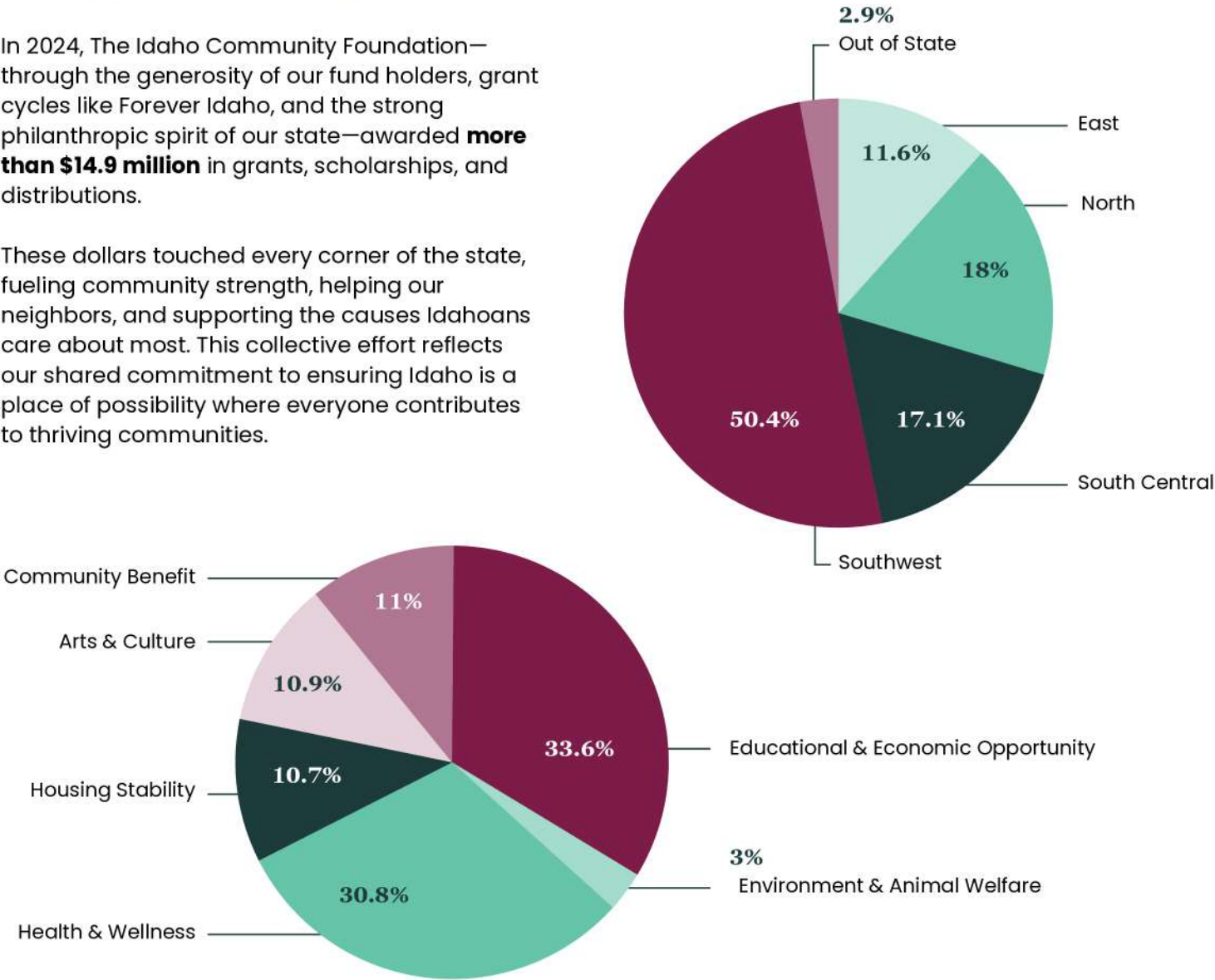

Together for Idaho

In 2024, The Idaho Community Foundation—through the generosity of our fund holders, grant cycles like Forever Idaho, and the strong philanthropic spirit of our state—awarded **more than \$14.9 million** in grants, scholarships, and distributions.

These dollars touched every corner of the state, fueling community strength, helping our neighbors, and supporting the causes Idahoans care about most. This collective effort reflects our shared commitment to ensuring Idaho is a place of possibility where everyone contributes to thriving communities.



The causes Idahoans care about are as diverse as our landscapes. The largest investments in 2024 focused on strengthening education, increasing access to opportunity, and supporting the health and wellbeing of our communities. Forever Idaho



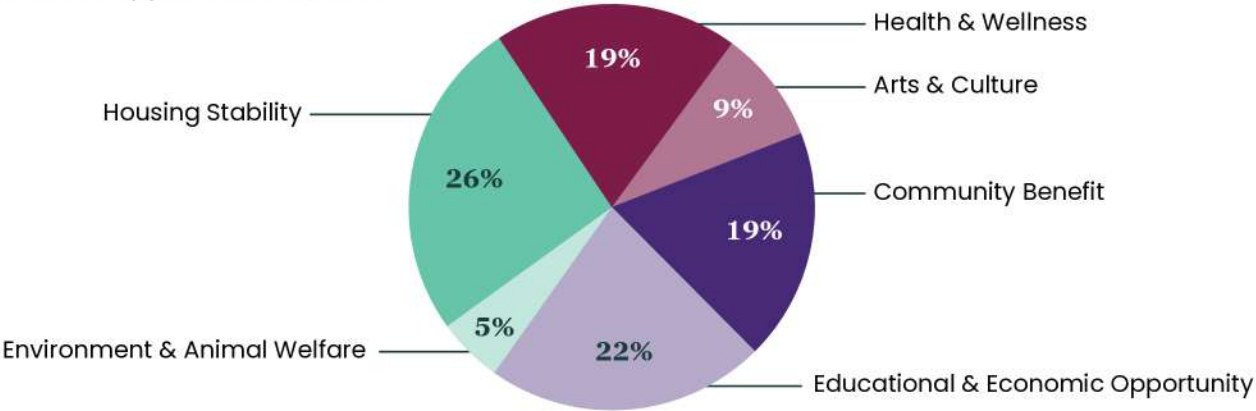
Forever Idaho represents the heart of community philanthropy across our state. Generous Idahoans contribute to these funds—either to a specific region or to the statewide Forever Idaho fund—because they believe in empowering local solutions to local needs.

Some donors choose to support causes like housing, education, or food security, while others give to meet the most pressing needs.

In 2024, more than \$1.1 million was awarded to 211 nonprofits in 43 counties through Forever Idaho grants.

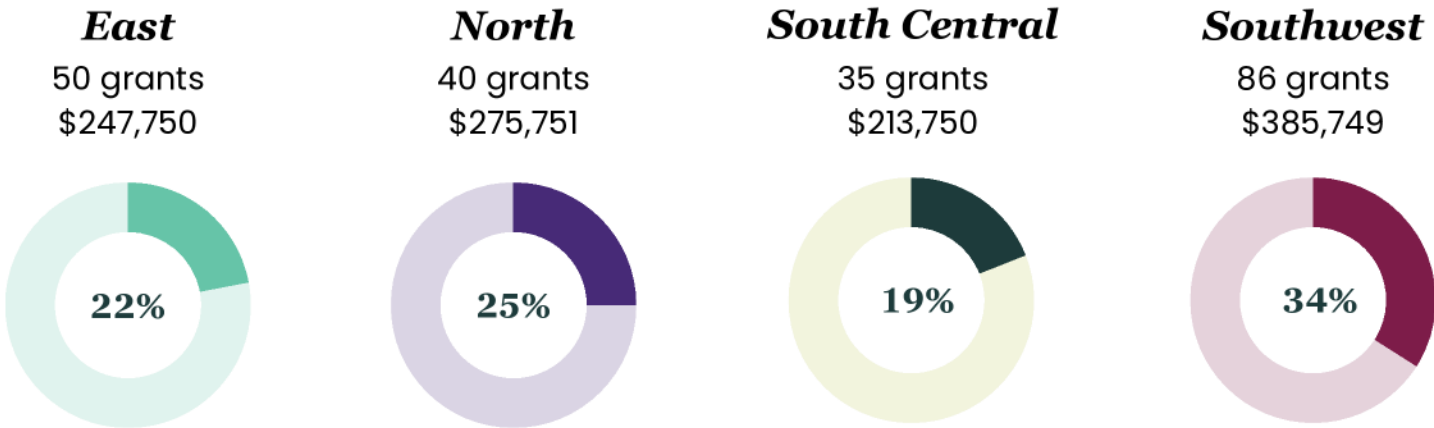
These funds are awarded annually through an open grant application process. Community based organizations from across Idaho apply for funding, and applications are reviewed by ICF’s Regional Councils —volunteers who live in and understand their regions. The final grant decisions are approved by our Board of Directors, ensuring alignment with donor intent and community priorities.

The chart below is an interesting illustration of how 2024 Forever Idaho grant dollars were distributed compared to region population. For example, the North Region, with 20% of Idaho’s population, received 25% of the grant funds. Each year, the pool of available funds changes based on donor contributions and fund activity. 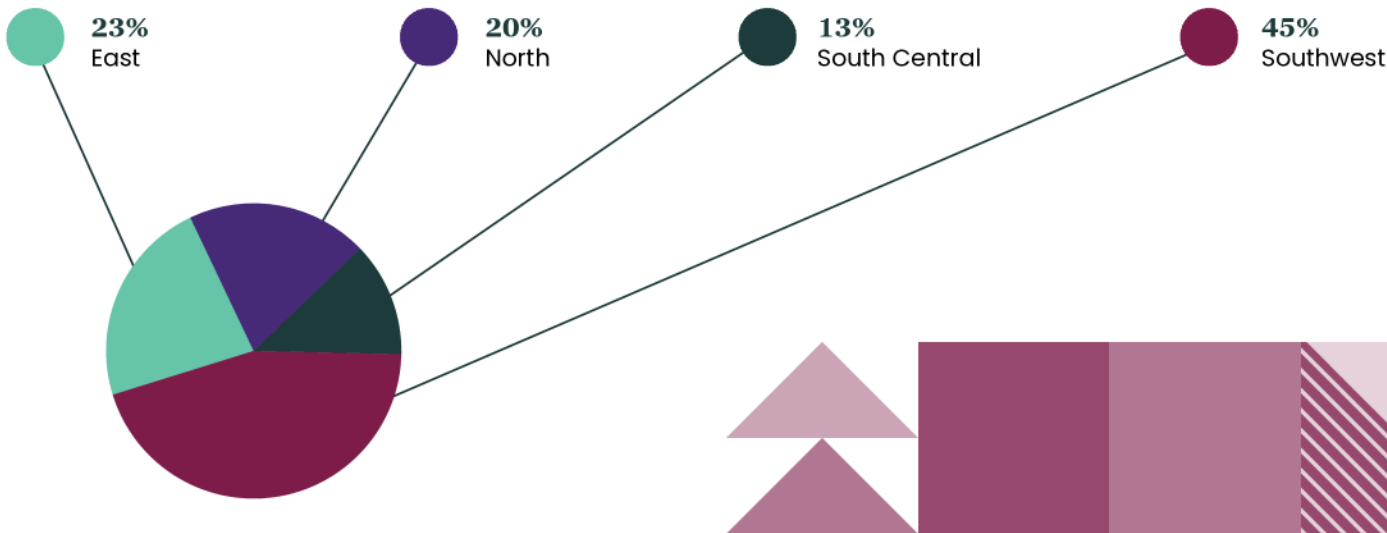
2024 Forever Idaho Grants by Region

In 2024, several remarkable funds at The Idaho Community Foundation crossed the \$1 million+ milestone in giving, demonstrating the power of sustained philanthropy to transform Idaho communities.

Honoring a Legacy Through Opportunity

Since 2000, the John William Jackson Fund has been a tribute to the life and passions of John Jackson, a Meridian native, scholar, musician, and mountaineer. Established by family and friends, the fund advances academic scholarships, performing arts access, and outdoor sporting opportunities for Idaho youth. In 2017, the fund hit its first \$1 million in cumulative giving, and in 2024, it reached another significant milestone – \$2 million—further proof of the lasting impact one person’s legacy can have.

With grants supporting college scholarships, music education, and outdoor experiences, the fund ensures young Idahoans have access to opportunities that align with John’s adventurous and intellectual spirit.

Corporate Philanthropy at Its Best

In South Central Idaho, another milestone was reached as the Chobani Community Impact Fund exceeded \$1 million in grants awarded since its inception in 2018. Focused on food security, senior care, education and community health, Chobani’s investment in Idaho has made a tangible difference for thousands of residents.

“Chobani sets a gold standard for corporate philanthropy,” said Twin Falls Mayor Ruth Pierce, who also serves on The Idaho Community Foundation board. “Their unwavering commitment showcases how businesses can empower communities by investing in meaningful solutions to pressing challenges.”

This year’s grants supported vital programs such as meal deliveries for homebound seniors, food pantry assistance, and health initiatives for vulnerable populations. Beyond funding, Chobani’s employee-led review panels ensure that resources are directed where they are needed most, reinforcing the company’s deep connection to the region.

New Funds in 2024 *East Idaho*

We welcomed several news funds originating from Eastern Idaho this year!

Abraszewski Trail Fund (Agency) – Distributions from this Fund will be used for the extension and maintenance of the Abraszewski Trail, which is part of the Bannock County Metropolitan Planning Area's network of bicycle and pedestrian paths.

Arrington Scholars Fund #2 (Advised) – The Fund was established to honor and remember Woodrow E. Arrington, a former Chairman of the Board of Directors for the Bank of Commerce.

Bill Allen Memorial Fund (Agency) – Grants from the Fund will be used by the Salmon Public School Foundation for scholarships and general support in honor of Bill Allen.

Donnie Ray Hudson and Donnie Ray Hudson Jr. Scholarship Fund (Designated) – Annual distributions from the Fund will be made to Idaho Falls High School to be used to award post-secondary scholarships to students enrolled in its Automotive, HVAC, or Welding programs in honor of Donnie Ray Hudson and Donnie Ray Hudson, Jr.

E.J. and Brittney Infanger Champion of Character Scholarship (Agency) – Grants from the Fund will be used by the Salmon Public School Foundation to award scholarships to honor E.J. and Brittney Infanger.

Lemhi County Historical Society Endowment Fund (Designated) – The Fund was established by Dr. Valerie Brackett and Nikolaos Monoyios (The Founders) to create an endowment for the support of the Lemhi County Historical Society (LCHS) in perpetuity.

Paul and Zelma Woodward Family Scholarship Fund (Designated) – The Fund was created to honor long-time Franklin residents, Paul and Zelma Woodward, who were consistent champions for youth and higher education. Annual distributions from the Fund will be used to provide post-secondary scholarships to students graduating from Preston High School.

Salmon Whitewater Park Association Fund (Agency) – Created by the Salmon Whitewater Park Association to be used for maintenance and improvements to the park.

Scoutomaty Enterprises Fund (Advised) – Created by George and Gina Katsilometes of Pocatello to support the nonprofits and causes that are meaningful to them.

Orchard Ridge Senior Living Resident Relief Fund (Agency) – This Fund was created by Orchard Ridge Senior Living in Coeur d'Alene to continue its mission of providing a faith-based loving home that honors older adults by supporting those residents in Assisted Living and Memory Care who need financial assistance to cover their cost of care.

Romey and Stephen Fund for the Visual Arts (Advised) – This fund was created to support the visual arts and art education in the Sandpoint area, especially painting, drawing, printmaking, ceramics, and sculpture.

Greater Coeur d'Alene Community Foundation Endowed and Non-Endowed Funds (Affiliate Field of Interest) – This affiliate Fund was created to contribute to the quality of life throughout the greater Coeur d'Alene area by enhancing and fostering charitable giving and philanthropy. Kevin Zumwalt Grangeville Community Foundation Fund (Affiliate Field of Interest) – Created through the estate of Kevin Zumwalt to provide support for projects within the city of Grangeville that benefit parks, recreation sites and sports venues.

North Idaho Women and Their Money Conference and Scholarship Fund (Special Project) – The Project Funds were created to educate and empower local women of all ages and socio-economic backgrounds to achieve greater financial confidence, security, and independence. A Community That Cares

Coeur d'Alene's strong community spirit turned into action in May 2024, exceeding all expectations. At the North Idaho Celebration of Philanthropy, nearly \$400,000 was pledged in just 15 minutes to launch the Greater Coeur d'Alene Community Foundation, an affiliate of The Idaho Community Foundation. This new fund will strengthen local nonprofits, schools, and organizations—ensuring support stays in the hands of those who know the community best.

ICF Board Member Heidi Rogers and a group of local leaders saw an opportunity to deepen local philanthropy. "This community is different. It's special," Rogers said. "Simply, we are a community that cares." That generosity was on full display as donors stepped up to build a lasting resource for North Idaho.

The enthusiasm spanned generations. A group of young professionals, the "Backyard Bunch," pledged \$50,000 to kickstart the foundation—proving the future of giving in North Idaho is bright. With an advisory committee of local residents, the foundation will direct funds where they're needed most. As early supporter Dr. Mary Sanderson put it: "I think this is a great thing for the community."

The momentum is just beginning. The generosity shown that day will fuel change for years to come, proving that when Coeur d'Alene sees a need, they rise to meet it—together.

Pay It Forward Scholarship Fund (Scholarship) – The Fund was created by Stephen and Leslie Goddard of Mountain Home to provide postsecondary scholarship assistance to graduates of Mountain Home High School.

Rupert Elks Lodge Scholarship (Scholarship) – Created by the Benevolent & Protective Order of the Elks Lodge #2106-Rupert to provide financial assistance to graduating seniors of Minidoka County and Cassia County high schools who plan to pursue a degree or certification in career-technical education or vocational education.

It will offer emerging artists the opportunity to immerse themselves in the vibrant community of the Idaho Shakespeare Company, facilitating housing, travel, and a per diem to ensure their full engagement in the creative process. By granting access to organizational resources, mentorship, and collaborative experiences, the Fellowship aims to empower fellows to hone their craft, expand their artistic vision, and contribute meaningfully to the theater landscape. Through this initiative, we seek to cultivate a diverse and dynamic group of theater makers who will inspire and elevate the art form for years to come.

Charles and Ronda Baines Charitable Fund (Advised) – The purpose of the Fund is to support charitable causes as recommended by the designated advisors.

Greater Boise Rotary Foundation (Field of Interest) – This fund was created by the Greater Boise Rotary Foundation to support nonprofit organizations in Ada County.

George and Sondra Juetten Charitable Fund (Advised) – Created by George and Sondra Juetten of Boise to support worthy causes and organizations in Idaho.

Gwendolyn Brunelle Fund (Advised) – The Fund was created by Andy and Betsy Brunelle in memory of their daughter, Gwendolyn (Gwen) Brunelle. Gwen was an animal lover from an early age and went on to participate in and become a leader within the Idaho 4-H community. She showed rabbits for many years, including at the Western Idaho Fair and through American Rabbit Breeders Association (ARBA), winning awards at local and national competitions.

Larry and Cathy Kirk Charitable Fund (Advised) – The Fund was created by Larry and Cathy Kirk of Marsing to support vocational training for Marsing High School students.

McCall Arts and Humanities Fund (Agency) – The Fund was created to support the arts and humanities in the McCall area.

Melba Memorial Scholarship Fund (Scholarship)
The Fund was created by the family of Grover Michael Loening of Melba to honor his memory and those that have been lost through tragedies in and around the community of Melba by providing post-secondary scholarships to students within the Melba School District and to provide financial support to Melba High School students participating in school-sponsored educational travel opportunities.

New Funds in 2024 *Statewide*

We welcomed several news funds originating from individuals or organizations whose philanthropic goals have a statewide reach.

Claire Horn Foundation (Field of Interest) – The Fund was established by the Claire E. Horn Revocable Trust, as amended to support various causes that were meaningful to Claire Horn.

Feed the Gap Charitable Advised Fund (Field of Interest) – Created to permanently support hungry children and reduce food insecurity among children in Idaho. Feed the Gap, Inc. feeds hungry children in their school cafeterias whose parents exist just above the poverty guidelines and do not receive federal nutrition assistance.

IBE Innovative Education Fund (Field of Interest) – This Fund shall support Idaho Business for Education's mission and will provide support to educators to purchase technology, develop curriculum, advance educational leadership, and innovative programs that help students succeed academically and which leads to the highly educated and skilled workforce Idaho needs.

Idaho Association of TRIO Professionals Endowment (Agency) – This Fund was created by the members of the Idaho Association of TRIO Professionals to be used as a scholarship to benefit limited-income, first-generation youth and adult students in Idaho TRIO programs as they pursue college, career, and technical higher education opportunities.

Idaho FFA Foundation Houck Family Farm Scholarship Fund (Agency) – This Fund was created to provide scholarship support for FFA members pursuing secondary education or other.

Steve and Barbara Chatten Trust Scholarship (Scholarship) – The Fund was created to be used as a yearly scholarship for a university student of Native American heritage who is registered on the rolls of a Native American Indian tribe with preference to the Blackfoot tribe or a tribe indigenous to Idaho such as the Nez Perce tribe.

Investing in Solutions

The Supportive Housing Investment Fund (SHIF)

Thanks to the collective power of philanthropy, The Idaho Community Foundation is home to the Supportive Housing Investment Fund (SHIF) for Ada County. A collaboration between ICF, the City of Boise, Our Path Home, local healthcare providers, and community organizations, SHIF is addressing one of the most critical challenges in Ada County: permanent solutions to chronic homelessness.

Why Permanent Supportive Housing?

We know that affordable housing alone isn't enough for those facing mental health challenges, disabilities, or substance use disorders. That's why Permanent Supportive Housing (PSH) pairs stable housing with essential services like case management, counseling, employment assistance, and healthcare—proven to help individuals remain housed and thrive*.

The impact is measurable. In just five years, New Path Community Housing has helped reduce emergency service use by 5,569 days and saved \$8.8 million in public costs. With sustainable funding, we can scale this success, ensuring fewer people fall through the cracks.

A Pioneering Public-Private Partnership

The City of Boise catalyzed this effort with a \$7.5 million investment – ICF's largest fund of its kind to date – and they aren't alone. Saint Alphonsus Regional Medical Center, Simplot, Micron, Blue Cross of Idaho Foundation, ICCU, Idaho Power Company, McAlvain Companies, and PSK, America and several private donors have all stepped up – recognizing that housing stability strengthens entire communities.

This collaborative funding model ensures that resources are pooled, professionally managed, and directed where they have the greatest impact – a structure that could be replicated in communities across Idaho.

Philanthropy in Action

With a goal of raising \$15 million, SHIF is positioned to expand access to permanent supportive housing, creating a long-term, scalable solution to homelessness.

A Legacy of Determination and Compassion



For Anne G. Glass, philanthropy is about action—identifying a problem and creating a solution. As the founder of Feed the Gap, Inc., she has dedicated herself to addressing one of

Idaho's most pressing challenges: childhood hunger.

Now, as a member of The Idaho Community Foundation's Legacy Society, Anne is ensuring her commitment to feeding children in need will continue for generations to come.

Her path to philanthropy was anything but ordinary. Growing up on a remote cattle ranch near Jordan Valley, Oregon, Anne lived without electricity or phone service, developing resilience and resourcefulness that would shape her future. At 18, she left for Boise State University, where she became president of the Alpha Chi Omega sorority and secured its long-term presence on campus.

Anne's career took her from advertising—where she won a prestigious "Sammy" award—to investment advising, holding key positions at firms like Dean Witter Reynolds, UBS Paine Webber, and Merrill Lynch. Her expertise led to an appointment on the Public Employees Retirement System of Idaho (PERSI) Board, where she helped strengthen the fund's financial health. She later became an expert witness in securities litigation, advising national regulatory agencies.

At the height of her career, Anne's life took an unexpected turn when she was diagnosed with cancer in 2004. A series of strokes followed, leaving her unable to work. As she fought to regain her health, she embarked on a journey of self-discovery that changed her perspective—and her purpose.



During five weeks in a Tibetan monastery in Nepal, Anne had the rare opportunity to meet the Dalai Lama. Their conversation was transformative, reinforcing her belief in

compassion and the power of individual action.

Later, at a private dinner with Madeleine Albright in Washington, D.C., Anne reflected on the responsibility each person has in solving society's challenges. One issue stood out: childhood hunger.

More than 67,590 children in Idaho experience food insecurity*, yet many do not qualify for federal nutrition assistance. These kids come from working families—earning too much to receive help but too little to afford consistent meals. This gap, she realized, was one she could help bridge.

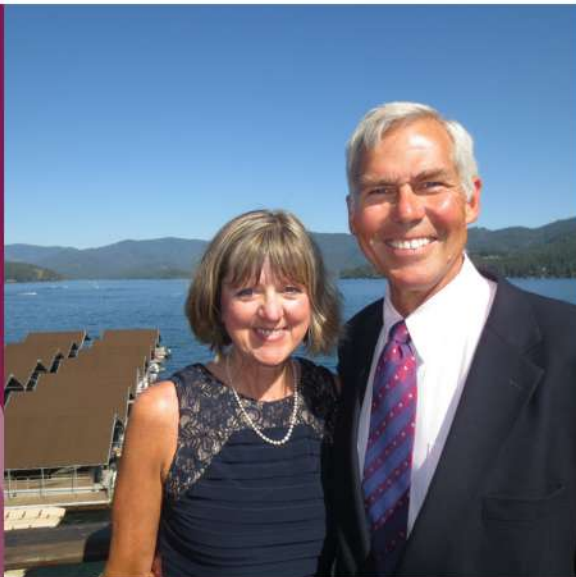
She founded Feed the Gap, Inc. to discreetly provide school meals to children who would otherwise go hungry. Working directly with schools, the organization ensures that students receive breakfast and lunch without drawing attention to their family's financial struggles.

Her story is a powerful reminder that one person's determination can change lives. Her legacy of compassion and action will feed not just children, but hope—for Idaho's families today and in the future.

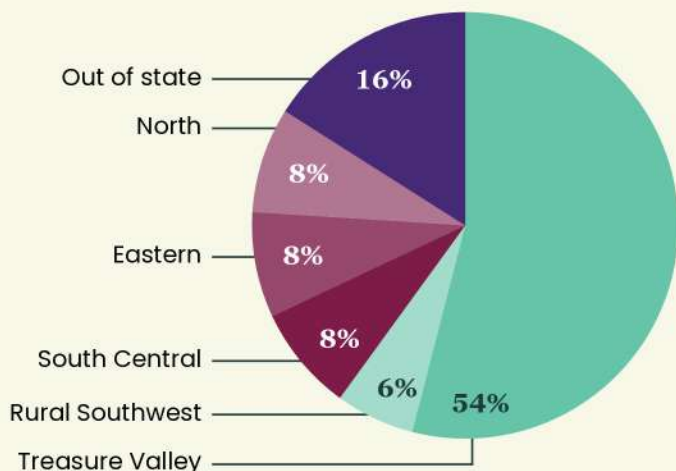

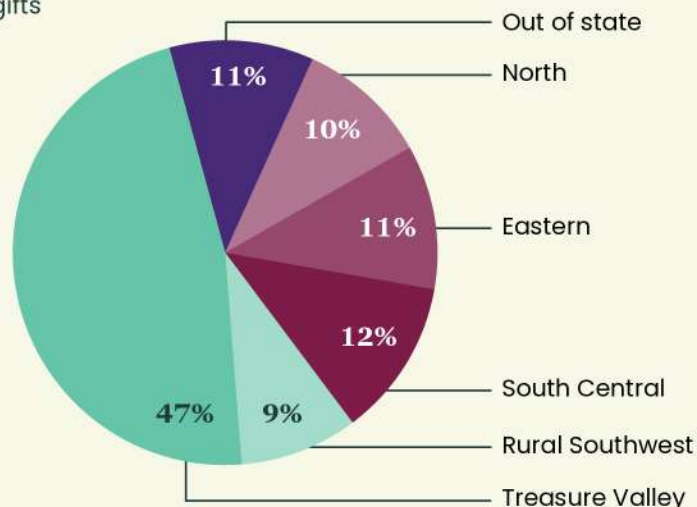

Thank you for your incredible generosity in supporting nonprofits, schools, and community organizations across Idaho. This past year was one of remarkable impact, culminating in record-breaking grantmaking, new funds, and a strategic merger that strengthens our collective ability to serve Idaho communities.

Since The Idaho Community Foundation was established in 1988, your generosity has created lasting change. Together, we have given more than \$192 million in grants, and in 2025, we are poised to surpass the \$200 million milestone!

In 2024 alone, you made an extraordinary difference. At your request, we distributed more than 2,000 grants, scholarships, and organization distributions totaling over \$14.9 million to strengthen Idaho communities. Additionally, hundreds of ICF fundholders, donors, and Legacy Society members contributed more than \$24.8 million to charitable giving funds, ensuring ongoing support for the causes that matter most.

These contributions continue to grow. Our endowed investment return for 2024 was 10.7%, with a 10-year return of 7.4%. Non-endowed investments also performed strongly, helping us reach total assets of nearly \$283 million by the end of 2024. 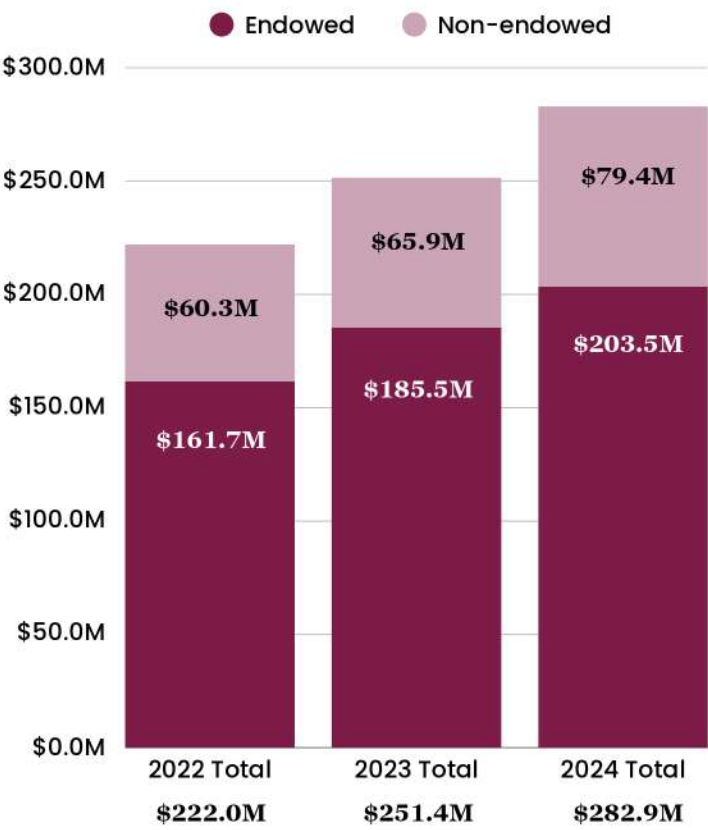
Total Assets

The Idaho Community Foundation closed the year with nearly \$283 million in total assets—the highest in our history. This milestone reflects strong investment performance and continued donor generosity.

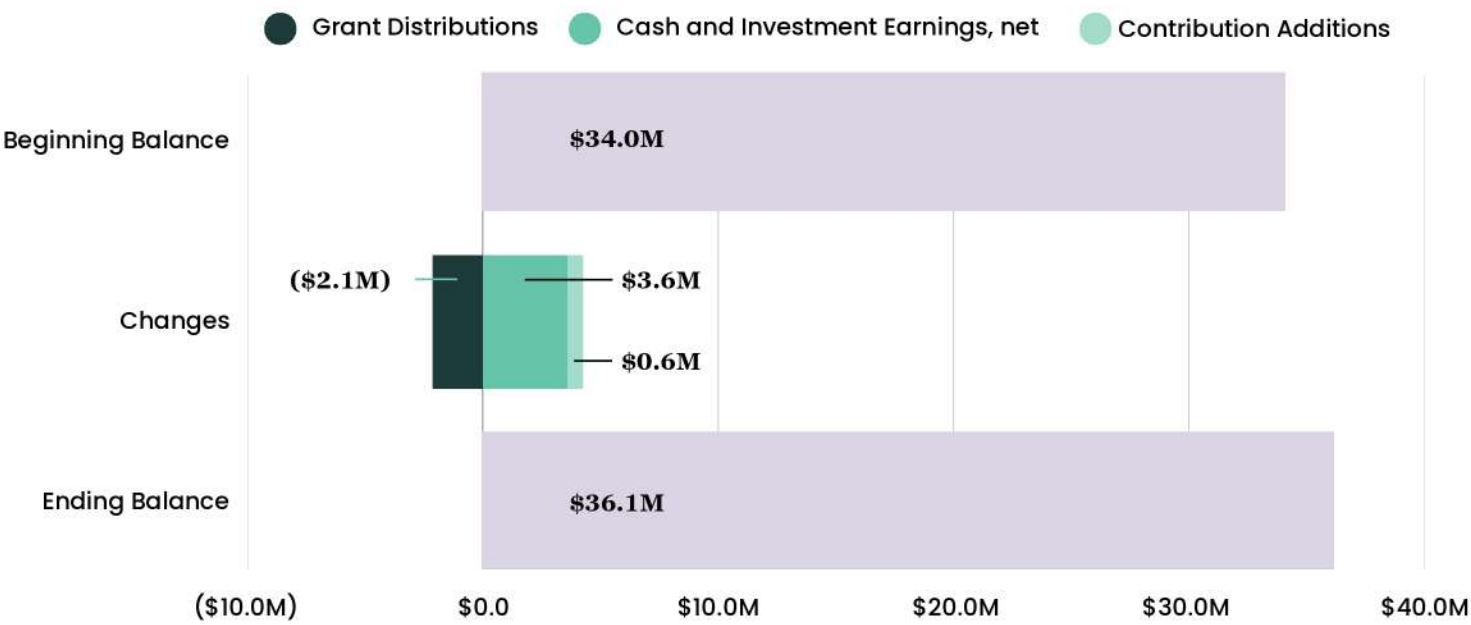
With more than \$24 million in net investment earnings, our Investment Subcommittee and investment partners played a critical role in preserving and growing the charitable resources entrusted to us.

\$2.1M Change in Funds Held on Behalf of Organizations

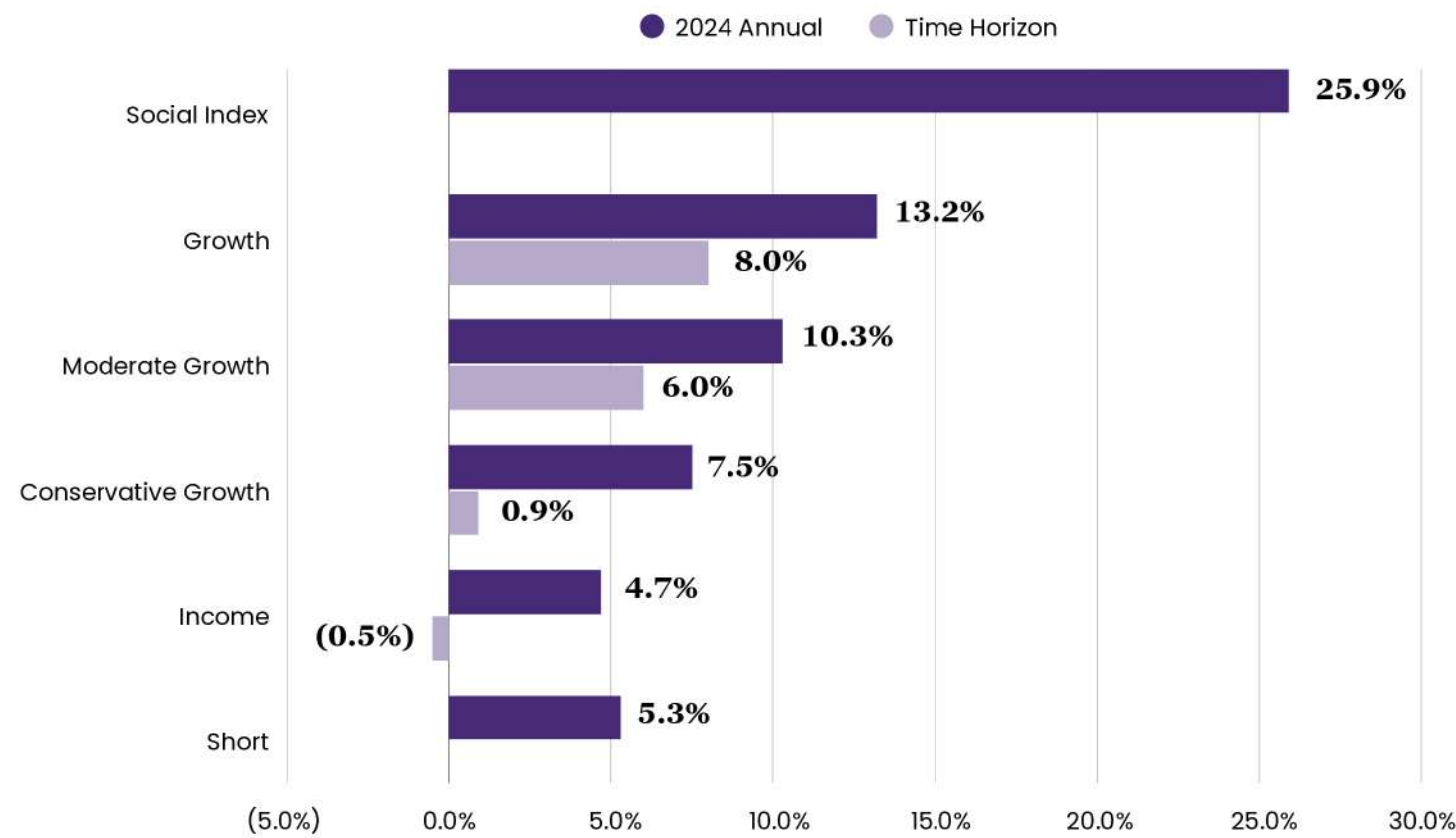


Non-endowed Cash and Investments

Target Asset Allocation



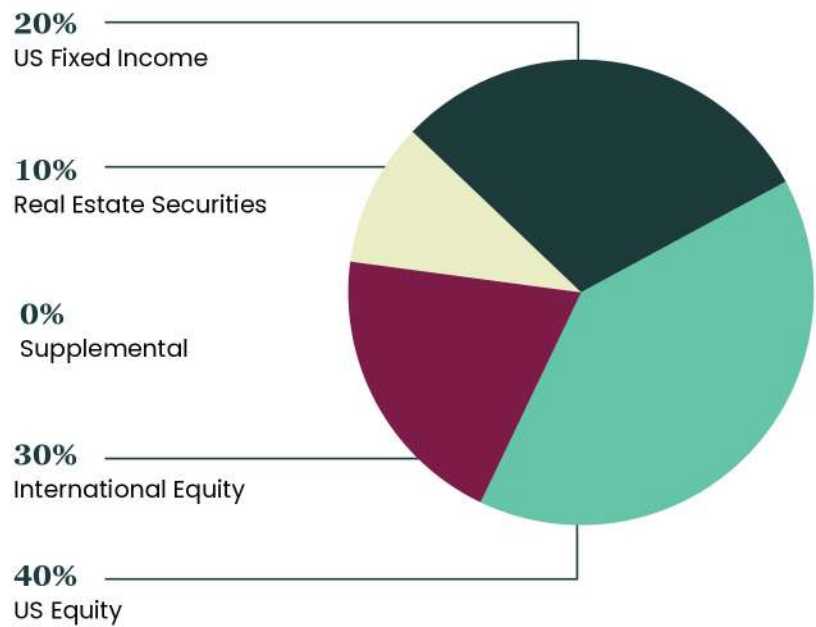
Rates of Returns



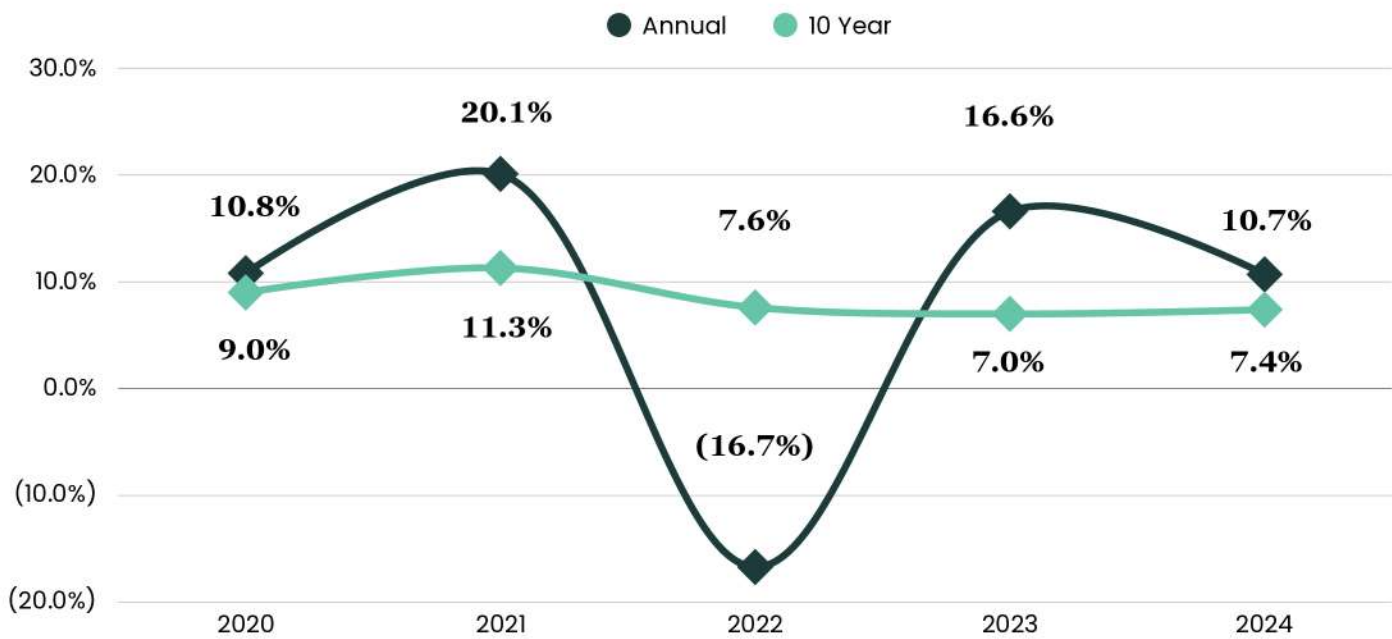
Endowed Investments
