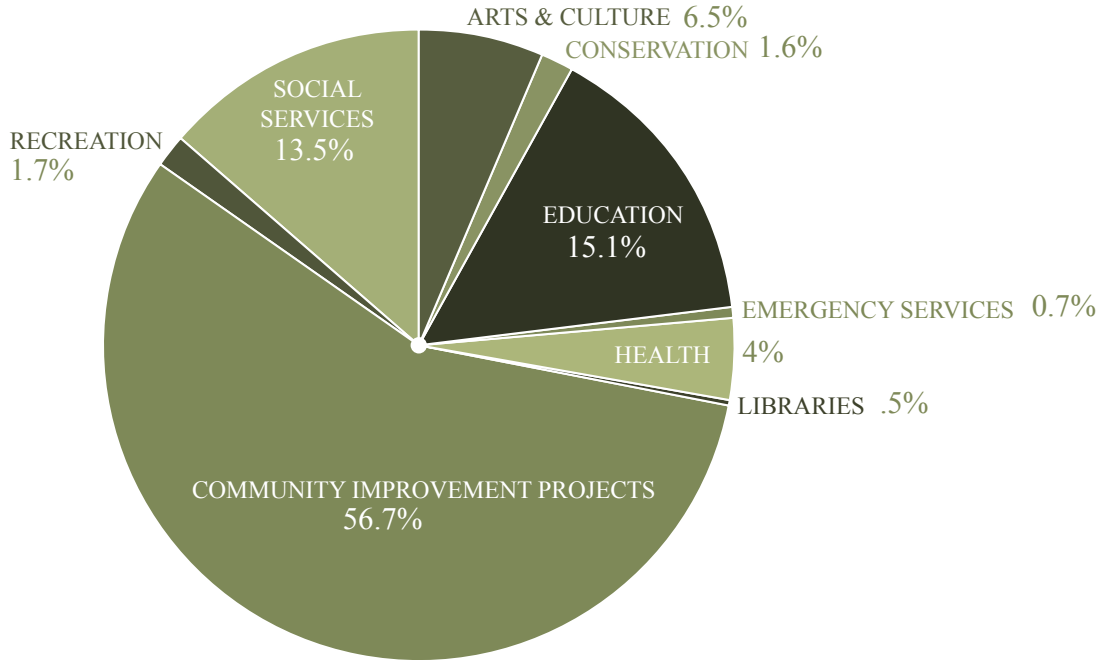

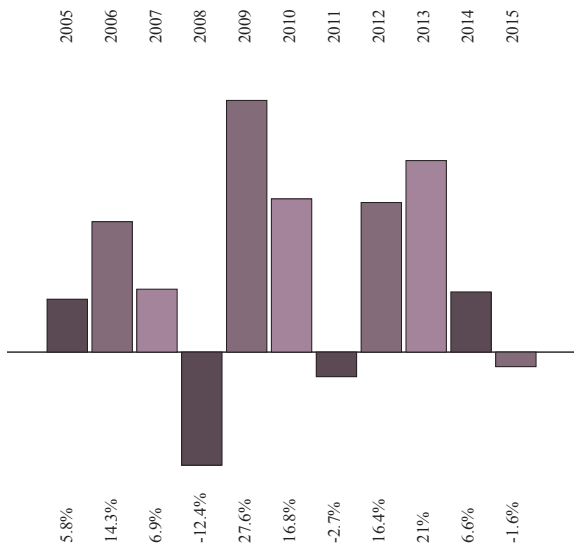

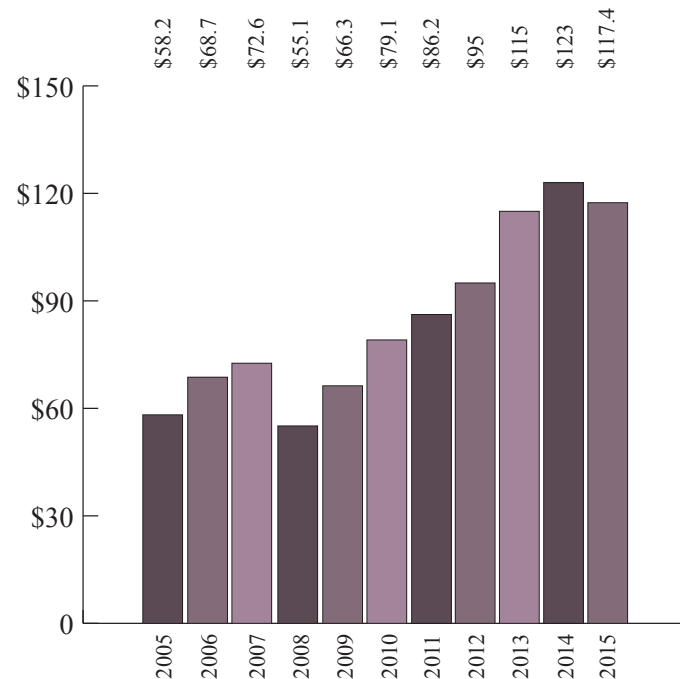
How ICF grant dollars were distributed

ICF President and CEO Karen Bilowith took the helm at ICF in February, following the retirement of former President and CEO Bob Hoover. She previously led the Community Foundation for the Greater Capital Region in Albany, NY.

What are your first impressions of Idaho?

People love living here and it's apparent when you interact with them. They're friendly and helpful. When they find out I'm from out of state, one of the first things they ask is "Do you love Idaho?" not whether I miss anything about New York.

The beauty and diversity of the natural environment is stunning. I've traveled to each part of the state and it's all beautiful – even the flat parts. People really appreciate their surroundings here and love them. In upstate New York, not all people love and appreciate the natural surroundings or take time to use them.

I love the independent spirit of the West and the pioneer attitude that still exists hundreds of years later.

You've dedicated your entire career to philanthropy. When and how did you decide it would be your life's work?

It wasn't intentional or deliberate. It was a lucky accident. I was an econ major in college and was focused on how economic strategies could influence communities. I thought I would be working on economic policy at the governmental or international level.

In the early 90s when the AIDS and HIV crisis was really impacting my generation, I was working on AIDS-related policy, which led to a job at the Red Cross. I saw that policy, programming and philanthropy can all be connected.

What opportunities do you see for ICF in Idaho's philanthropic landscape?

Bob (Hoover) and the ICF staff have grown ICF's statewide footprint over the years and that puts us in a strong position for the future. The transfer of wealth is something ICF and Idaho should be thinking about capturing to help our communities.

In Idaho the wealth looks different – a lot of it is in property, land and natural resources. Young people may not have the same commitment to their communities as their parents and grandparents. When people see the real importance of giving to community and how ICF can make their gifts last forever, that's a powerful message.

What goals do you have for ICF?

I want us to think strategically about what our next stage of growth looks like so that we can have an even greater impact on our local communities and meet our mission of enriching the quality of life throughout Idaho. I'd like us to become more of a resource to other nonprofits and to partner with funders and organizations to improve our communities both locally and regionally.

What are your favorite aspects of community foundations?

I love the dual role we play with donors and the community. We serve as a matchmaker or a bridge, and community foundations are the only organizations that do that in a way that's really meaningful for both donors and recipients. And I love collective philanthropy because donors at any life stage and income level can participate.

Since you brought it up, is there anything you miss about New York?

I miss my family and friends, of course, and I miss the work the community foundation was doing. We were in the middle of a really exciting project. I'm confident they will be successful, but it was hard to leave without seeing it to completion. I definitely don't miss my nearly 2-hour commute.

Large Grant: \$20,000 For Hansen High School

As an 18-year-old senior at Hansen High School in the Magic Valley, Gabe Casady has been thinking about college for a while. He wants to go into medicine or be a teacher and he's not sure whether to start at a two-year community college or enroll in a four-year school.

One of the main factors influencing his decision is cost and it's for that reason that Gabe and several of his classmates are taking advantage of dual credit high school classes that allow them to earn College of Southern Idaho (CSI) credits. Gabe is taking four dual enrollment classes this year and will graduate high school with a semester of college already accomplished.

"I'm getting these classes out of the way and saving money," Gabe said.

Hansen is a rural town of 1,200 about 10 miles east of Twin Falls. The high school received a \$20,000 grant from the Idaho Future Fund in ICF to offer dual credit courses in math, chemistry, health science and English. The credits would normally cost \$195 for a 3-credit course, but the ICF grant means they are free.

Hansen High senior Marina Mendoza is taking three dual credit classes this year. She wasn't sure she would go to college because she thought it would be too challenging, but after getting a B in a dual credit math class last year she started thinking about getting a business management degree with an eye toward opening her own business.

"These classes showed me I can do this work," Marina said. "They really boosted my confidence."

Andrea Robbins teaches science at Hansen High and she thinks the dual credit courses help ease the transition from high school to college for her students.

"That first year of college can be tough and this helps

them have a college academic experience and makes them more ready," she said.

Students use college textbooks and take the same exams as their college peers. Robbins and the other faculty who are teaching the dual enrollment courses work closely with CSI faculty. The only difference is that some classes that are a semester long at CSI are year-long at Hansen High.

This is the second year that Hansen High has offered dual credit courses. Last year, the school offered two dual credit classes and this year there are five. Principal Kayla Kelly said she believes their popularity will continue to increase.

"Many of our students have parents who didn't go to college so this is a wonderful opportunity for them," she said.

The Idaho Future Fund in ICF provides grants from \$10,000 to \$20,000 to support gaps in educational programs. Focus areas include preschool scholarships, charter schools, public schools and public school libraries. To learn more, visit www.idcomfdn.org/Regional_Cycle.

Regional Competitive Grant: Snake River Community Clinic

When Dr. Glenn Jefferson and Dr. Stamey English founded the Snake River Community Clinic in Lewiston 16 years ago they thought – and hoped – that it wouldn't be needed for long.

“We knew there was a significant need, but we were hoping the clinic would be a temporary stopgap and that we would have universal healthcare,” Jefferson said.

Instead, the clinic has become a lifeline for patients like Teresa Gross. Free medication, exams and dental care from the clinic mean she can afford rent, food and the eight prescriptions totaling \$600 per month that she needs to control her chronic allergies and asthma.

“There have been times when I just get one or two of the medications I need and then try to make do with (over-the-counter) inhalers,” Gross said.

Clinic visits more than doubled after Idaho didn't expand Medicaid when the Affordable Care Act, also known as Obamacare, was implemented. Most clinic patients fall into the “Medicaid gap” where they make too much for Medicaid assistance but not enough for ACA subsidies.

Jefferson said the success of the clinic is “both gratifying and discouraging.”


“We feel like we're putting our finger in a dike,” he said.

Executive Director Charlotte Ash said the clinic provided \$4.6 million in services to nearly 1,800 patients in 2015. Funding comes from several sources, including ICF's Northern Region Competitive Grant Cycle, which has provided nearly \$53,000 in grants to the clinic since it opened.

Despite the growth and success, Ash echoes Jefferson's thoughts about wishing the clinic was no longer needed.

“We would love to be obsolete because that would mean our patients all had affordable medical care and health insurance,” Ash said.

The value of the land recorded as an asset is equivalent to the county assessed values for 2015.

(2) The Foundation accounts for its funds held as agency endowments in accordance with FASB Accounting Standards Codification Topic ASC 958 (previously Statement of Financial Accounting Standards No. 136). ASC 958 specifically requires that if a Not-For-Profit Organization (NPO) accepts cash or other financial assets from a donor, agrees to use those assets on behalf of or transfer those assets to establish a fund at a community foundation, and specifies itself as the beneficiary of that fund, the community foundation must account for the transfer of such asset as a liability. For financial reporting purposes, distributions from agency endowments in the amounts of \$708,218 in 2015 and \$655,332 in 2014 are not included in the reported Grants and Distributions of the Foundation.

Small Grant:

\$750 for Native American culture class
at Lillian Vallely School

It's a Thursday afternoon at the Lillian Vallely School on the Fort Hall Reservation in eastern Idaho. Fifth-graders Evin*, K'Chele*, Nivea* and Siouxdel* are seated around a low, rectangular table chatting excitedly. As they talk, they reach into the clear plastic boxes in front of them, which are filled with bright, iridescent seed beads.

Each girl slides a tiny bead onto a needle and then expertly stitches, winds or weaves it into intricate earrings, medallions, bracelets and headbands. This is culture class at Lillian Vallely, which is offered every day to teach students about traditional beadwork, clothing and more.

The Lillian Vallely School is an Episcopal day school serving Native American children in grades K-5, most of whom are members of the Shoshone-Bannock Tribes.

The culture class is possible thanks to a \$750 grant from the F.M., Anne G., and Beverly B. Bistline Foundation Fund in ICF. Since 2001, the school has received nearly \$850,000 in ICF grants from several different ICF funds.

Kenzie Stonecipher teaches the culture class. "It's really important for students to learn how to bead. Not very many people still know how to do it and this tribe is known for beadwork. The elders think these are important lessons that should be carried on."

Stonecipher used to watch her mother and grandmother bead, but she didn't learn it herself until she was an adult. "I didn't have any interest in it at the time. I wish I'd had a class like this to encourage me."

Siouxdel, 11, has attended Lillian Vallely since kindergarten. She likes the relaxed atmosphere of culture class and the skills she's learning. "I feel pride knowing about my culture and heritage. My mom, grandma and aunts all bead and I like being able to do it too."

Kathy McDaniel, the school's business manager, said support from ICF has made a big difference for her students.

"It is an amazing experience to see a child's eyes light up when they realize people they have never met care about their success," she said. "It drives them to work harder; to not to give up on themselves, as well as gain an appreciation for what others do for them. Our students realize and value the extra activities they are presented with are sponsored by the incredible people that support the Idaho Community Foundation."

The Pauline Becker & Dorothy Simplot Memorial Endowment Fund

I have chosen to memorialize two amazing pioneer women with this endowment fund who, like millions of others, were the very backbone of the development of America. Although neither of them traveled in wagon trains moving across the western states, both of them lived the rural life of work and survival.

Dorothy Haxby Simplot was born Dec. 31, 1883, to a wealthy farming family near Dubuque, Iowa. She was an educated young lady, even studying the piano as a girl. Several years after marrying Charles “Dick” Simplot in 1905 she moved by train with her three small children (Jack being only six weeks old according to his story) to join her husband on a homestead in Declo, Idaho.

Many movies have shown us what life was like in a homestead cabin. This truly must have been a great adjustment for her – farm work, cooking, washing and scrubbing plank floors. Three more children joined the family. In spite of all these demands she was indeed a loving, kind and amiable person who was loved and respected by all the children. Jack enjoyed telling me about her. That she only lived to her mid-50s was something he always regretted.

Pauline Warmbier was born on Christmas Day, 1902, on a farm about 50 miles from Oshkosh, Wisconsin. The daughter of German immigrants, she had to leave home at age 14 to work in a button factory in a nearby town after her father suddenly passed away, leaving a family of

eight children. After several years she moved to Oshkosh for a better job and it was then that she met and married Edward Becker, a handsome divorcee 17 years her senior.

Pauline was a 4’11”, 90-pound dynamo who set the pace for all of the family. She helped with the milking on the Becker homestead, worked in the fields, cooked, cleaned and she would plant a huge garden every year where there was always room for her favorite flowers – zinnias and gladiola. In her spare time she had seven children, nurturing them during the worst of the Great Depression. Every Sunday we were all in one of the front pews at church 10 minutes early in our “Sunday best.” Yes, 10 minutes early. She lived until she was 87. The day of her heart attack, she dined out with my sister Lila, topping off a nice lunch with a big piece of pie.

As an addendum, I would like to draw attention to the big difference in the lives of these two ladies. It has to do with water, dams and electricity. Idaho, because of the need for irrigation, had electricity in the early 1900s, so that Dorothy was able to enjoy some of the daily life improvements as her husband prospered. On the other hand, rural Wisconsin was not furnished electricity until 1941, at the outbreak of WWII. What a difference a wash machine, refrigerator and milking machines made in the life of Pauline Becker! I can remember when “the lights came on.”
